Overview of the Quarterly School Manager Report

The Quarterly School Manager Report is a summary report on the finances and management of the School District of Philadelphia. It is prepared by the Office of Finance.

The purpose of the Quarterly School Manager Report is to provide senior management of the School District of Philadelphia with a summary of the District's progress in implementing the financial and management goals of the current fiscal year on both a "Year-to-date Actual" basis and on a "Forecast for Full Year" basis.

While the Quarterly School Manager Report focuses narrowly on the financial management of the District, it is important to keep in mind the real educational impacts to children and families of the District's financial status. Many schools lack a full array of resources and educational opportunities. Our financial plans are only effective to the extent that they provide for an adequate education of all public school children in Philadelphia.

The Quarterly School Manager Report contains the following reports and schedules:

Operating and Federal COVID-19 Relief Funds: The Quarterly School Manager Report presents a combined presentation of revenues and expenses for the principal operating funds, in addition to detailed revenue categories in the general, intermediate unit, and debt service funds; and expenditure and current budget information divided according to the District's functional hierarchy. Additionally, this report includes revenue and expenditures for Federal COVID-19 relief funds.

The principal operating funds of the District consist of a General Fund, Intermediate Unit (IU) Fund, and a Debt Service Fund. The District is required, as a result of its covenants to holders of fixed rate bonds of the School District, to deposit funds into its sinking funds during the current fiscal year to pay some of the debt service due in the next fiscal year.

For all quarters except the fourth quarter, the operating reports present quarterly year-to-date actuals for the current fiscal year and prior two fiscal years; the current full year projection and full year actuals or latest projection for the prior two years; and the year-to-date actuals as a percentage of the total year. The fourth quarter report presents the current year amended budget, current full year projection, the current year projected budget variance, and full year obligations for the prior two years.

Cash Flow: The Cash Flow section includes year-to-date cash flow and vendor payment information. The School District's adopted cash flow is based on the current fiscal year's adopted budget. The cash flow projections are updated to

reflect actual year-to-date results and changes to assumptions as to the timing of revenues and the payment of expenses which are made as a result of actual events. The vendor payments report includes the cash payments made to date in the fiscal year to the District's vendors. The list contains payments inclusive of operating and grants expenditures.

Personnel Reports: The Position Summary Report contains budgeted and projected Full Time Equivalent positions and current On-Board actual employees. Budgeted and projected positions are derived from the Office of Management and Budget personnel projection system reconciled to the Staffing Management System for school-based positions. Current On-Board employees are taken from the District's Advantage HR Staffing system and include On-Board employees at months-end with status codes 1 (Active), 2 (Acting), 3 (Long-Term Substitutes), and other codes for certain employee groups. There may be instances when the Count (Filled column) is fractional which represents an employee in a part-time position. The Quarterly School Manager Report also includes a Vacancy Report which is a listing of teacher vacancies by school for operating and grant funds.

The Position Report and Vacancy Report may vary due to timing differences, different definitions of what constitutes a vacancy, and different definitions of when a vacancy is considered filled.

Supplementary Materials: This section of the Quarterly School Manager Report contains additional materials related to the operations of the School District.

The Debt Service Schedule is the District's current fiscal year projected operating debt service budget (net of refunding), which depicts each bond series outstanding broken down by principal and interest due in the current fiscal year. "Trapped funds¹" reserved or released in the current year are shown separately.

The Capital Projects reports include a listing of the District's activities related to capital projects, in addition to detailing the monthly year-to-date cash balances for all bond funds held to pay capital projects.

The documentation also includes information regarding the school allocation methodology, major grants funds and corresponding descriptions, school-by-school Title I budgets and spend, a summary of minority and women business enterprise participation, and a listing of the data posted on the District's website as part of the Open Data Initiative.

¹ In order to be compliant with Local Government Unit Debt Act (LGUDA) guidelines that all debt be amortized, bonds with a bullet maturity must have debt service payments set aside to pay the future principal and interest when it comes due as if there were an amortization schedule. Those funds that are set aside are considered trapped and are released when the payment is due.

Introduction

Overview

The School District of Philadelphia's Quarterly School Manager Report for the period ended March 31, 2024 represents forward-looking statements and any such statements are subject to a variety of risks and uncertainties that could cause actual results to differ materially from those that have been projected.

The District currently projects operating and Federal Relief Act revenues and sources of \$4.596 billion and operating and Federal Relief Act expenditures and uses of \$4.485 billion, resulting in a surplus of \$111.0 million excluding changes in reserves, and a surplus of \$101.6 million including changes in reserves². The District is projected to end FY24 with a \$784.5 million positive ending fund balance.

The District's projected FY24 fund balance of \$784.5 million represents a \$93.8 million increase relative to the FY24 Adopted operating and Federal Relief Act ending fund balance of \$690.6 million.

Third Quarter Report Revised Projections

The District's currently projected year-end fund balance of \$784.5 million, as of March 31, 2024, represents a \$36.5 million increase from the December 31, 2023 projection, due to a \$45.2 million increase in revenue and an \$8.7 million increase in expenditures. FY24 adjustments since the December projection include:

• Revised FY24 projected revenues

- \$9.9 million increase in Local Tax Revenue due to a \$6.9 million Business Use and Occupancy Tax, a \$1.5 million increase in Liquor Sales Tax, a \$1.3 million increase in School Income Tax, and a \$0.2 million increase in Ridesharing Revenue;
- \$5.5 million increase in Local Non Tax Revenue due to a \$5.1 million increase in Interest and a \$0.4 increase in all other Local Non Tax Revenue:
- \$31.4 million increase in State Revenue due to a net \$22.7 million increase in projected Transportation reimbursement, a \$4.3 million increase in projected Retirement and Social Security reimbursement, and a \$3.9 million increase in Basic Education Subsidy due to a change in the projected payback of Intermediate Unit transportation advances, and an increase of \$0.5 million in all other State Revenue;
- \$.04 million increase in Federal Revenue due to a small adjustment in the Federal Debt Service Subsidy;

² Transfers from Reserves are not included in the total expenditures. FY24 transfers from reserves are an unfavorable net (\$9.4) million for trapped funds related to debt service.

- (\$1.2) million reduction in Federal Covid-19 Relief Revenue due to a
 (\$1.3) million reduction in Retirement reimbursement, offset by a \$0.1 million increase in Federal ESSER III-ARPA Relief Revenue; and
- o a (\$0.4) million reduction in Other Financing.

Revised FY24 projected expenditures

- \$15.2 million net increase in District Operated Schools expense primarily due to a contract ratification bonus associated with the one-year contract extension with the Philadelphia Federation of Teachers and an increase in Capital Programs and Environmental Services expense related to the timing of one-time Federal Relief Fund projects, partially offset by a reduction in projected Utilities expense;
- \$4.8 million net increase in Charter Schools expenses comprised of a \$6.3 million increase in tuition due to an increase in special education enrollment and increases in cyber charter school enrollment, offset by a reduction of (\$1.4) million in Charter Transportation expense;
- \$0.7 million net increase in Other Non District Operated Schools expenses due to a \$0.9 million increase in Transportation costs, offset by a (\$0.2) million reduction in tuition expense;
- \$0.9 million net increase in Administration expenses;
- (\$13.0) million decrease in Undistributed Budgetary Adjustments primarily due to an increased credit to offset anticipated reductions and timing delays in Administration expenses as well as a reporting shift of the Additional Support reserve funds to District Operating Schools and Administration lines.

Year Over Year Comparison

Revenues – Year Over Year

Year-to-date revenue variances are primarily driven by the following:

- FY24 year-to-date Local Tax Revenue as compared to FY23 is lower by (\$234.6) million due primarily to the timing of the receipt of Real Estate Tax payments from the City of Philadelphia. Payments for the period in FY23 came in prior to March 31st, whereas in FY24, those payments were received in early April, which makes up the majority of the (\$286.7) million reduction. This is further reduced by net (\$2.4) million reduction in Liquor Sales Tax, Ridesharing Revenue, and Public Utility Realty Tax, offset by a \$31.0 million increase in Cigarette Tax, a \$20.0 million increase in Business Use and Occupancy Tax, and a combined \$3.6 million increase in School Income Tax and Sales Tax revenue; FY23 year-to-date Local Tax Revenue as compared to FY22 is higher by \$179.5 million, primarily due to a combined \$176.4 million increase in Real Estate Tax revenue, a \$14.8 million combined net increase in Liquor Sales Tax, School Income Tax, Sales Tax, and Ridesharing revenue, offset by a (\$11.7) million combined net reduction in Business Use and Occupancy Tax, Cigarette Tax, and Public Utility Tax revenue;
- FY24 year-to-date Local Non-Tax Revenue as compared to FY23 is \$18.8 million higher due to a \$9.1 million increase in the Grant from the City of Philadelphia, an \$8.1 million increase in Interest, and a \$1.9 million increase in Miscellaneous Non Tax revenue, offset by a net (\$0.3) million reduction in all other Local Non-Tax Revenue; FY23 year-to-date Local Non-Tax Revenue as compared to FY22 is \$29.7 million higher due to a \$17.8 million increase in Interest, a \$10.5 million increase in the City Grant, a \$1.4 million net increase in all other Local Non Tax Revenue;
- FY24 year-to-date State Revenue as compared to FY23 is \$98.9 million higher due to a \$68.1 million increase in Basic Education Funding, a \$24.5 million increase in Transportation reimbursement, a \$9.1 million increase in Debt Service reimbursement, and a net \$5.2 million increase in Retirement and Social Security reimbursement, offset by a (\$7.5) million reduction in Special Education funding and a (\$0.5) million reduction in Vocational Education funding; FY23 year-to-date State Revenue as compared to FY22 is \$124.0 million higher due to a combined \$111.9 million increase in State subsidies for Basic Education, Special Education, Vocational Education, and Special Education Program, and a \$17.2 million net increase in retirement and social security reimbursement, offset by a (\$3.0) million reduction in Nurse Services and Medical & Dental and a net (\$2.1) million reduction in Transportation subsidies;
- FY24 year-to-date Federal Revenue as compared to FY23 is \$0.2 million higher; FY23 year-to-date Federal Revenue as compared to FY22 is (\$6.3) million lower, due to the timing of the receipt of the Federal Debt Service Subsidy;
- FY24 year-to-date Federal Relief Revenue is \$48.2 million higher than FY23 and FY23 year-to-date Federal Relief Revenue is (\$285.1) million lower than FY22 due to the timing of reimbursement and the distribution of funds across fiscal years;

- Other Financing Sources year-to-date vary each year due to debt borrowing or the sale of property, and were \$3.3 million in FY24, \$7.8 million in FY23, and \$0 in FY22 at the end of the third quarter.

Expenditures – Year Over Year

The following table shows a year over year comparison of third quarter year-to-date expenditures from FY22 to FY24.

Significant differences in year-to-date expenditures in FY24 compared with prior years include:

- A. Salaries Year-to-date salaries are \$33.4 million higher in FY24 compared to FY23, and year-to-date salaries are \$72.6 million higher in FY23 compared to FY22, primarily due to contractual increases as part of collective bargaining agreements.
- B. Benefits –Year-to-date benefits are \$5.4 million higher in FY24 compared to FY23 and \$45.0 million higher in FY23 compared to FY22, primarily due to increases associated with the above-mentioned collective bargaining agreements.
- C. Non-Personnel Services (NPS) FY24 year-to-date NPS expenditures are \$228.0 million higher compared to FY23 primarily due to increases in Charter School Tuition and Central Book Allotment expenses, partially offset by a reduction in Debt Services expenditures; FY23 year-to-date NPS expenditures are \$27.5 million higher compared to FY22 primarily due to increases in debt, capital, and utilities expenses, offset by a reduction in charter tuition expense due to reductions in overall charter enrollment relative to the prior year, and a reduction in educational technology expense due to a one-time expense that took place in FY22.

Issues and Risks

As noted in prior quarterly reports, the issues below continue to be key drivers that will impact the finances and operations of the District.

Strategic Plan Implementation

On June 1, 2023, the Board of Education adopted the *Accelerate Philly Strategic Plan*. The plan outlines 62 Strategic Actions that will guide the District over the next five years towards achieving the Board of Education's Goals and Guardrails as well as the District's ultimate vision, "to prepare students to imagine and realize any future they desire." *Accelerate Philly* delineates five critical Priority Areas:

- 1. Priority Area 1: Improve safety and well-being (physical, social-emotional, and environmental);
- 2. Priority Area 2: Partner with families and community;
- 3. Priority Area 3: Accelerate academic achievement;
- 4. Priority Area 4: Recruit and retain diverse and highly effective educators; and
- 5. Priority Area 5: Deliver efficient, high-quality, cost-effective operations.

Collective Bargaining Agreements

The District completed a one-year agreement with the Philadelphia Federation of Teachers in FY24 and completed longer-term agreements with the remaining unions in FY22 and FY23, providing greater predictability for its largest expenditure - its workforce. As the current agreements expire, new long-term contracts will be collectively bargained. Below are the current end dates of all labor contracts:

- Philadelphia Federation of Teachers: August 31, 2025;
- Commonwealth Association of School Administrators: August 31, 2025;
- School Police Association of Philadelphia: August 31, 2025;
- Service Employees International Union Local 32BJ: August 31, 2026; and
- Unite Here! Local 634: September 30, 2027.

State Funding Formula

In response to the February 2023 ruling by the Commonwealth Court, the State's 2023 Basic Education Funding Commission (BEFC) was charged with reviewing the distribution of state funding for basic education to Pennsylvania's 500 school districts. On January 11, 2024, the BEFC adopted a report stating that the School District of Philadelphia's adequacy gap is \$1.419 billion and recommended a five-year plan to reach statewide adequacy targets that would increase year-over-year funding by \$242.7 million for FY25.

On February 6, 2024, the Governor proposed a budget that was largely in line with year one recommendations from the BEFC which called for an additional \$242 million in Basic Education Funding for the School District of Philadelphia.

As the deadline for the State to pass its budget gets closer, the District will continue to monitor progress of the Executive and Legislature as they work towards meeting the Constitutional promise to adequately and equitably fund K-12 education.

With fair funding in place, the District could execute the *Accelerate Philly Strategic Plan* with fidelity and purpose, thus enacting the kind of transformation that could counteract more than a century of school underfunding, and finally give students the education that they deserve.

Phase Out of Covid-19 Federal Relief Funding

Although the District is projected to end FY24 with a significant fund balance, the majority of the revenue associated with COVID-19 Federal Relief Funding will expire September 30, 2024. The projected fund balance covers less than three months worth of District expenses and is needed to help the District bridge any gaps that will result from the loss of funding.

FY25 Budget Development

As part of the FY25 budget development process, the District is proactively implementing strategies to reduce the District's projected structural deficits in the coming years, and retain some level of fund balance revenue to cover that transition and any future gaps in funding that may exist if increased funding is not available.

On March 28, 2024, the District presented and the Board approved a Lump Sum Budget focused on maintaining the positions that were added to schools using Federal Covid-19 Relief Funds, hiring and supporting highly qualified teachers, and ensuring that the District has standards-aligned core instructional materials. The Budget also included funding for the *Accelerate Philly Strategic Plan* priorities, and further detailed the fiscal sustainability measures that the District is undertaking to bridge the funding gap noted above.

Conclusion

The Quarter 3 report includes revenue and expenditure data as of the three-quarter mark of the fiscal year and provides a more informed projection of the ultimate District spend for FY24. The Quarter 4 report will refine these projections as we have more complete data at the end of the school year, and begin the fiscal year closing process.

The challenges caused by the pandemic and inflationary pressures, the age of District buildings, and climate and safety, continue to create a dynamic fiscal challenge for the School District. Federal Relief funds have allowed the District to both navigate the

impacts of the pandemic and effectively manage a short-term period of budgetary surplus. As Federal Relief funds and current labor agreements expire in the near future, the District must prudently manage its finances in order to meet the Board of Education's Goals and Guardrails, appropriately endow the *Accelerate Philly Strategic Plan* and circumvent the impending structural deficit.


FY24 Current Projection Operating & Federal Relief Fund Budget Summary

FY24 Current Projection

The District's budget consists of multiple funds: operating, categorical, capital, print, and food services. The Adopted Operating and Federal Relief Act budget includes a \$4.596 billion revenue budget and a \$4.485 billion expenditure budget.


Operating and Federal Relief Fund Revenues

District revenues are provided by the state, city, federal governments, and other sources.




Approximately 58.6 percent of local revenues are generated from real estate tax. The remaining 41.4 percent of local revenues come from other taxes and fees and a City grant. Approximately 68.5 percent of state revenues are provided through the basic education subsidy. The remaining 31.5 percent of State revenues come from other subsidies and reimbursements.


Operating and Federal Relief Fund Expenditures

The District's FY24 projected operating and Federal Relief Act budget includes operating and Federal Relief Act expenditures of \$4.485 billion. Of the \$4.485 billion, the District spends 88.0 percent of its budget directly on District, charter, and other non-District schools, with the remainder of the budget expended on debt service (7.5 percent), District administration (4.3 percent), and Other Financing (0.2 percent).



Approximately 58.5 percent of the operating budget goes to District operated schools (including District administration). Of this amount, 92.6 percent goes to instruction, instructional support and other direct supports to schools. The remaining 7.4 percent is budgeted for District administration.

The remaining 41.5 percent is budgeted for charter schools (31.0 percent), debt service (7.5 percent), non district operated schools (2.8 percent), and other financing (0.2 percent).

A school's budget consists of school-based allocations and centrally-allocated resources. The school-based allocations include both operating and grant resources. The operating resources are allocated for administration, teachers (enrollment driven + prep), school support positions, and discretionary funds. Grant resources are provided by Title I and Title II, SIG, and other grants. The centrally-allocated resources include positions such as special education, nurses, ESOL teachers, facilities, and security.
