#### **BIDDER'S QUESTIONS**

#### Q1: Section 01-1165 Underground Storage Tank Removal

Spec section calls for removal and disposal of 400 tons of regulated fill, If necessary. Unit Price No. 1 calls for 600 tons of contaminated (regulated fill). Is the unit price of 600 tons in addition to the base bid quantity of 400 tons?

- A: DELETE the reference to "up to 400 tons" and REPLACE with " an estimated 600 tons, to be paid on a unit price basis". The estimated quantity of 600 tons is the amount included in the base bid per Unit Price No. 1.
- Q2: Does the <u>Unit Price No. 1 "Disposal of Contaminated Fill</u>" pertain to the Underground Storage Tank, UST; or does it pertain to other areas within the Project?

# A: Unit Price No 1 pertains to the excavated soil surrounding the UST, however far it may extend, due to leaks, spills or other cause

Q3: The unit prices are to be totaled and included in the base bid amount. The \$300,000. allowance for additional ACM's is also to be included in the base bid amount. This seems to be an overlap. Please confirm that both unit prices and allowances are to be totaled and included in base bid amount.
